**Partner in Vocation**

Effective immediately, the following procedures set forth the Partner in Vocation program as we described briefly in our 2015 Easter newsletter:

- 1) **Mission:** This is an education fund for training Chinese seminarians and other religious in China and overseas.
- 2) **Your prayer intentions:** The seminarian or any religious benefiting from your sponsorship will pray daily for “donors' intentions”. You may send us your prayer intentions in writing. We will file them accordingly. We cannot, however, send your prayer intention to individual religious in China receiving your sponsorship, not only for fear of their security, but also because we do not match your donations against each individual. Your donations are kept in a pool for distributions. We will send your contributions from this pool to the seminary rector or an individual directly if he is studying overseas. The intentions will remain unchanged from the previous period unless you notify us otherwise.
- 3) **Beneficiary of your prayer intentions:** Each sponsor may list as many persons as he or she wants as the beneficiaries of the prayers. Each sponsor may also sponsor more than one religious at full cost as described in item 4, or sponsor one religious at partial cost for any amount.
- 4) **Cost of the sponsorship:** It is US\$1,200 for sponsoring one religious for one year, or US \$600 for six months renewable at end of the period as described in item 5. However, you may also sponsor a religious less than \$1,200 a year for any amount you may choose as a partial donor. You have no obligation to continue a recurring donation and may stop or change your recurring donation at anytime by writing to us.
- 5) **Sponsorship cycle:** All sponsorships are to be uniformly expired twice a year on the last day of March and of September. For the new sponsorships, their first expiration dates may, therefore, be up to three months short or longer than the cycle in order to keep the expiration date uniformly on the last day of March and of September. For instance, for those sponsors starting on June 30 for 6 months, their first expiration dates will be on September 30 same year, which is 3 months shorter than the 6-month period. For those starting on July 1 for 6 months, their expiration dates will be on March 31 next year, which is three months longer than the 6-month period. Please refer to item 7 for the uniformly fixed expiration dates for new sponsors. After the first expiration dates, the future expiration dates will always have exactly 6 months or 12 months on the last day of March or of September.

With the uniform expiration dates twice a year, the Foundation will send you a reminder no later than March 1 or Sept 1 for renewal of your sponsorship expiring on March 31 or September 30 accordingly each year.

- 6) **Automatic Charge:** You may use your credit card to charge the sponsorship fees for certain amount each month automatically by using our E-Donate page on our website. For instance, if you wish to sponsor one seminarian in full, you may instruct our E-Donate page to charge your credit card \$100 each month on certain date, totaling \$1,200 a year. Or, you may charge any amount each month, totaling whatever amount that you may be able to afford a year.
- 7) Starting and expiration dates for the first year:
